Roles and Responsibility of Tobacco Control Monitoring Committee

1. No sale of tobacco inside the premises of the institution.
2. No smoking or chewing of tobacco inside the premises of institution by students/teachers/other staff members/visitors.
3. Display of sign boards/warning boards in prominent places of Campus
4. No sale, storage or usage of tobacco in the radius of within 100 meters of the educational institution.
5. Counsel the students who are using tobacco.
6. Integrate tobacco control activities such as follow
 - a. Awareness through Seminar, Street Play
 - b. Organize debate/essay writing and Quiz competition
 - c. Assemblies for taking pledge against tobacco
 - d. Conduct of slogan Writing & Poster making Competition
7. Enforce the provisions of COTPA, 2003
8. Impose and collect the fine against the violation of Section 6 (a & b)
