CIRCULAR

MANDATORY ADDITIONAL REQUIREMENT FOR EARNING DIPLOMA OR UNDERGRADUATE DEGREE

It is hereby notified to all students enrolled in Gyanmanjari Innovative University (GMIU) that, in order to be globally competitive engineers and professionals, it is essential to develop not only strong technical and professional knowledge but also soft skills, teamwork and leadership qualities, and an entrepreneurial outlook.

To achieve these objectives, students must actively participate in co-curricular and extra-curricular activities, in addition to their regular academic pursuits.

Accordingly, the following mandatory requirements are to be fulfilled by all students for the award of their Diploma or Undergraduate Degree:

1. Activity Points Requirement

- 4-Year Undergraduate Program: Minimum 100 Holistic Activity Points are required, in addition to passing academic courses.
- Lateral Entry Students (3-Year): Minimum 75 Holistic Activity Points are required, in addition to passing academic courses.
- 3-Year Diploma Students: Minimum 75 Holistic Activity Points are required, in addition to passing academic courses.

2. Multiple Entry and Multiple Exit (MEME) Option

• For students opting for the Multiple Entry and Multiple Exit (MEME) scheme, Activity Points will be considered on a pro-rata basis, corresponding to the year of exit and level of award (Certificate, Diploma, Advanced Diploma, or Degree).

4. Guidelines for Activity Points

- Points must be accumulated through co-curricular and extra-curricular activities as per the list provided in Annexure-1.
- Students may choose activities according to their interests and distribute them over the semesters.
- Each student must prepare a documented file every semester with proofs of activities undertaken
 and upload the points on ERP during given duration. This file will be verified and approved by the
 Faculty Mentor appointed by the Head of Department.

5. Important Notes

- Activity Points will not carry any grades or marks and will not affect SGPA/CGPA.
- Final examination results will not be released until the student fulfills the minimum Holistic Activity Points requirement by the end of their program.
- All students are therefore directed to actively participate in recognized co-curricular and extracurricular activities and ensure timely documentation to meet the mandatory Holistic Activity Point requirements.
