Q. What is Pharmacy?

Q. How many seats are available in course?

A. 100 seats are available for Bachelor of Pharmacy course.

Q. What is criteria/eligibility for taking admission in B. Pharm courses?

Candidates should have passed in class 12th or passed in 10+2 examination with Physics and Chemistry and Biology/ Biotechnology/ Mathematics from any recognized Board with minimum 45% marks for General category and 40 % for SC/ST/SEBC candidate or its equivalent, as compulsory subjects along with one of the Biology / Mathematics. (Group B/AB/A)

Candidates who have passed 2-year Diploma in Pharmacy from institutions recognized by the PCI are eligible for admission to Second year (semester-3) of B. Pharm.

Candidates have taken a qualifying exam in any Higher Secondary Education in Gujarat or its equivalent decided by ACPC appointed by the Gujarat State government are eligible to apply for the admission in B.Pharm programme in Gujarat

Candidates must appear for the GUJCET (Gujarat Common Entrance Exam.) for state quota admission.

Non- GUJCET candidates can get admission in management quota admission process.

50 % of total intake admission process carried out by ACPC and remaining 50% seats can process by Management admission process.

Age: Minimum age limit is 17 years on 31st December in the year of admission.

As per guideline of Govt of Gujarat, candidate passed 10 + 2 from selected open school is eligible.

પ્ર. બી. ફાર્મા કોર્સમાં પ્રવેશ લેવા માટે શું માપદંડ/પાત્રતા છે?

- જ .1. ઉમેદવારોએ ધોરણ 12માં પાસ કરેલ હોવું જોઈએ અથવા 10+2 પરીક્ષામાં ભૌતિકશાસ્ત્ર અને રસાયણશાસ્ત્ર અને જીવવિજ્ઞાન/બાયોટેકનોલોજી/ગણિત સાથે કોઈપણ માન્ય બોર્ડમાંથી સામાન્ય કેટેગરી માટે ઓછામાં ઓછા 45% ગુણ સાથે અને SC/ST/SEBC ઉમેદવાર અથવા તેના માટે 40% માર્કસ સાથે પાસ કરેલ હોવું જોઈએ. સમકક્ષ, બાયોલોજી/ગણિતમાંથી એક સાથે ફરજિયાત વિષય તરીકે. (જૂથ B/AB/A)
- 2. PCI દ્વારા માન્યતા પ્રાપ્ત સંસ્થાઓમાંથી ફાર્મસીમાં 2 વર્ષનો ડિપ્લોમા પાસ કરેલ ઉમેદવારો B. ફાર્મના બીજા વર્ષ (સેમેસ્ટર-3) માં પ્રવેશ માટે પાત્ર છે.
- 3. ઉમેદવારોએ ગુજરાતમાં કોઈપણ ઉચ્ચતર માધ્યમિક શિક્ષણમાં લાયકાતની પરીક્ષા આપી હોય અથવા ગુજરાત રાજ્ય સરકાર દ્વારા ACPC દ્વારા નક્કી કરાયેલ તેની સમકક્ષ પરીક્ષા ગુજરાતમાં B.Pharm પ્રોગ્રામમાં પ્રવેશ માટે અરજી કરવા પાત્ર છે.
- 4. ઉમેદવારોએ રાજ્ય ક્વોટામાં પ્રવેશ માટે GUICET (ગુજરાત સામાન્ય પ્રવેશ પરીક્ષા.) માટે હાજર રહેવું આવશ્યક છે.
- 5. ગુજકેટ સિવાયના ઉમેદવારો મેનેજમેન્ટ ક્વોટા પ્રવેશ પ્રક્રિયામાં પ્રવેશ મેળવી શકે છે.
- 6. ACPC દ્વારા કરવામાં આવતી કુલ પ્રવેશ પ્રક્રિયાના 50% અને બાકીની 50% બેઠકો મેનેજમેન્ટ પ્રવેશ પ્રક્રિયા દ્વારા પક્રિયા કરી શકે છે.
- 7. ઉંમર: પ્રવેશના વર્ષમાં 31મી ડિસેમ્બરે લધુત્તમ વય મર્યાદા 17 વર્ષ છે.



- 8. ગુજરાત સરકારની માર્ગદર્શિકા મુજબ, પસંદ કરેલ ઓપન સ્કૂલમાંથી 10 + 2 પાસ કરેલ ઉમેદવાર પાત્ર છે.
- Q. Do I have to clear NEET for pharmacy course admission?

A. No, it is not required for pharmacy admission; however, you have to appear in **Gujarat Common Entrance Test (GUJCET)** to get admission in pharmacy course. However, in case of vacant quota, students are eligible to admin without GUJCET.

Q. Can a candidate having supplementary in 10+2 also apply for admission in B.Pharm?

A. Yes, but such candidates should pass 10 +2 at the time of admission.

Q. Are candidates belonging to any State other than Gujarat eligible to apply?

A. Yes, all residents of India fulfilling educational qualifications are eligible to apply.
